My research has generated 109 papers in refereed journals including papers in the Lancet, BJOG, Obstetrics and Gynaecology, and Cochrane Library; more than 70 other scholarly publications including: a book published by Oxford University Press (1994); 40 research reports that have influenced Commonwealth and State government policy on maternity care; four project websites for disseminating information regarding study protocols and publications; one set of evidence-based guidelines; and >150 published abstracts and invited presentations and workshops.

Google scholar indicates that my publications in refereed journal have resulted in 4106 citations of my work since 1992, with an average citation rate in the past five years of >320 citations per year reflecting high citations for papers which have become seminal references in my field of research (h-Index = 34).
