CEO Protective Group Letter

We will soon be delivering Certificate qualifications in other security, justice and investigative courses. We are also delivering courses in General Safety and Security Awareness and HEAT (Hostile Environment Awareness Training).

We have partnerships with other Australian firms such as Integral Risk, R2S and Atlas Medical in the risk and security work space. We have also formed a formal partnership with nationally recognised and well-known Registered Training Organisation Learning Verve.

We sponsored the 7th Annual Australasian Police Drug and Alcohol Strategy in Brisbane in 2015 and presented to Police from around the globe on family violence and alcohol fuelled violence. And present regularly as Subject Matter Experts to organisations including Victoria Police on security and liquor licensing.
