

To The Royal Commission,

27.5.2015

I am an advocate to my granddaughter and my great grandson, because my granddaughter does not trust the present system, she went through so much during her pregnancy that no one wants to hear about it. After what I witnessed I am very disappointed with the present system.

When she was pregnant he was not happy, he call her names, would not help in any shape or form he verbally, mentally, emotionally abuse her. He came to my home at 100'clock at night then came to fight on the [REDACTED], my granddaughter heavily pregnant had to hide in the Garage, we afterwards went to the Police Station in [REDACTED]

[REDACTED] They were both not attended so we call [REDACTED] Police Station where Constable [REDACTED] told us if comes back to call 000 and to go and have an Intervention order out. But we did not do so in fear what can happen, and my granddaughter said he is the father of my child. She had to stop to work at the [REDACTED]

She was in and out of the emergency at [REDACTED] hospital, She had a major operation at [REDACTED] weeks pregnant, she had a bad infection the [REDACTED]. She ask him to help her instead he was over the phone abusing her telling her he had a dream, she died while giving birth and he was given the baby next he had another dream he was fighting for custody and that she was dead, after the phone calls she was crying and in a distress state it was torture to see what she was going through. We helped her and she was on her own to bring her son into the world. No emotional, physical or financial help from him, he was only torturing her over the phone and at last I told her not to answer his phone calls even very scared of what the outcome would be.

Her son was born [REDACTED] and everything was paid by her. He bought her to court to get custody of her son. He wanted to change his name he wants the child


to sleep over and when more than once the child returns from visitation; he has bruises which he hides and lies about he is just fighting to hurt her more and she is so scared that he can hurt her son that she does not report all the incident. The court says that until the child is hurt or kill there is no prove that he is not a good father, and he is very good at playing the victim. He has not been working for 8 yrs and more and collecting centerlink, and he is only [redacted] yrs he is leaving at [redacted] as a carer to [redacted]. He

changed his name [redacted] yrs ago for whatever reason, the system did not have a police check or a mental assessment and has even try to inquire where he was taking the child for visitation. In court when he did not get to change the child's name he waited for the judge to leave the court he swore at the child's solicitor and slam the door and left. A dad is not someone without compassion, should be working and should be responsible should be a role model for his son, not expecting him to be another generation of milking the centerlink, he is using as a bait to get to the mother. I will cut the story short but, what is the future for these women living in fear, and when the system will rectify the law and do something as soon as possible to protect women and children, because those husbands and partners will not change and will continue to play the victims. I feel very sorry for the women and for the children, and the system is playing with the future of children and in this case he is only [redacted] yrs old.

When he goes for visitation she fears that her son will not come, because he is so aggressive. He says that he is an alpha male and he must be listen to, and when he was working he worked as a [redacted] in a [redacted]

I hope that things will change soon, and more investigation be done and the women, mother be listen to. They should not be leaving in fear.
